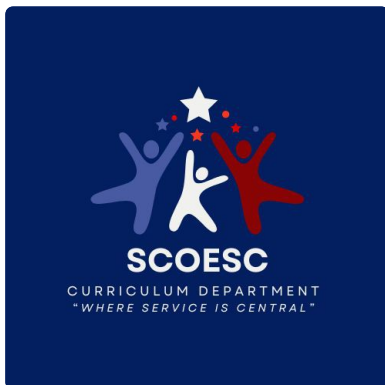

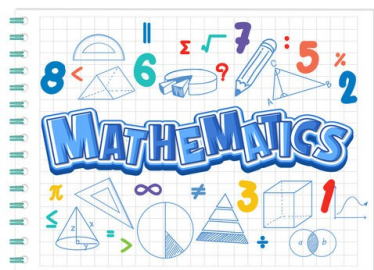

Professional learning in the Mathematics Community of Practice (CoP) will support math instruction aligned with [Ohio's Plan for K-](#)

[12 Mathematics](#). These sessions will be facilitated by a nationally recognized leader in math education, Dr. Sarah Powell from the University of Texas at Austin.

## Department Seeks Educators to Participate on OST Committees

The Office of Assessment is currently accepting applications for participants to serve on Content Advisory, Rubric Validation, and Fairness and Sensitivity committees for Ohio's State Tests in all grades and subjects.

These committees are specific to each Ohio's state test (e.g., Ohio's State Test in Grade 3 ELA or Algebra I End-of-Course Test). Ohio educators who serve as assessment committee members represent the variety of Ohio's schools and districts: public, nonpublic, career technical, urban, suburban, and rural. Some may work in higher education or serve in school districts or ESCs as





curriculum specialists, but the majority of the committee members are classroom teachers with varied years of teaching experience in the appropriate grade levels and areas of study. These committees meet in person in the Columbus area on an ongoing basis to review new test questions and materials as they are developed. The number and frequency of meetings depend on the volume of new test item development, but typically these committees meet once or twice annually.

### **Content Advisory Committees for All Subject Areas**

Content advisory committees review and evaluate test questions and related test materials to ensure that each question is a valid and appropriate measure of the Ohio Learning Standards for that particular subject area and grade level. These committees review

all test questions to advise the Ohio Department of Education and Workforce (Department) on whether each question is aligned with Ohio's Learning Standards, contains appropriate grade-level content, has the appropriate level of difficulty for the grade level, has correct and accurate content and is clearly written.

### **Rubric Validation Committees for Math and Science**

Rubric validation committees review student responses from machine scored items administered during the online embedded field test. The review is conducted to ensure the machine is scoring the items accurately. The committee can make changes to the scoring rubric of an item for clarity, accuracy and reliability.

### **Fairness and Sensitivity Committees**

Fairness and sensitivity committees review and evaluate test questions and related test materials to ensure that test questions are fair and unbiased for all groups of Ohio students. This explicitly includes gifted students. The primary purpose of these committees is to ensure that test questions do not promote or inquire about individual moral, social values, or beliefs. In addition, these committees ensure that questions do not disadvantage groups of students because of their race, ethnicity, gender, or disability. These committees also ensure that the variety of Ohio's student populations are represented in assessments and that material used neither offends nor stereotypes any student group.

### **Please note the following:**

- For committee members who are not under contractual obligations for the dates of the meeting, a monetary stipend of \$75 will be provided for attendance of each meeting day.
- Expense forms and reimbursement guidelines will be distributed and collected at the meeting.
- All eligible meeting participants will have the cost of substitute teachers directly reimbursed to school districts. Participants will receive reimbursement guidelines at the meeting and paperwork to give to their districts to complete for reimbursement.
- Training will be provided first thing in the morning on Day 1 so please be on time. Meetings are held 8:30am – 4:30pm with a lunch break (time for lunch is normally determined by committee).
- Participants will receive certificate of contact hours from the Office of Assessment approximately 4-6 weeks after the meetings are completed.

Those who are interested in participating on one of the assessment committees should complete [this application](#). Applicants must describe their experience in education, including expertise with Ohio's Learning Standards in their chosen subject area. Please note that content/learning standards expertise is not required for the fairness and sensitivity committees. Be sure to identify:

- grade level choice
- subject area assignment
- name of the committee preference (content advisory, rubric validation, fairness & sensitivity)

**Please be sure to include an active email address for notifications. Applications **MUST BE FULLY COMPLETED** to be considered for participation on a committee.**

Submit applications by 11p.m. EST on Sunday, Nov. 2, 2025.

Selected applicants will receive notification by Dec. 12. Please be sure to include an active email address for notifications. New committee members will receive detailed information about upcoming Summer 2026 meetings and logistics in their acceptance email.

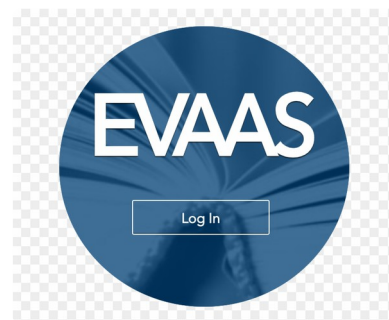
## Export Data Before the EVAAS Release

When EVAAS reports for the 2024-25 school year are released, some of the data that is currently on the site will no longer be available.

- Current student projections will be removed and replaced with new projections based on the most recent year of assessment data.
- Current Custom Student Reports will be removed.

In addition, district- and school-level users with Teacher Summary access will be able to access available prior year Teacher Reports and Teacher Composites with the 2025 EVAAS release. We still recommend printing these reports for teachers who might request prior-year Teacher Reports from their local administration.

If you would like to save value-added and student projection data that is currently available, you must print or export that data by October 21. EVAAS users are reminded to follow all local data policies when exporting or printing confidential data.

## SCOESC Gifted Services Update



The High School Academic Competition season is off to an exciting start, with the Wheelersburg team currently undefeated and leading the standings. Student participation is strong, and the level of competition is especially high this year!

Our Middle School Quiz Bowl Tournament will take place on October 15, followed by the Jr. High Tournament on October 22. We're pleased to have 9 teams registered for the Middle School competition and 12 teams for the Jr. High level, with a total of close to 200 students participating. We're looking forward to two evenings of academic challenge and collaboration. These events are open to the public and we typically have large audiences for these events.

The ESC Artist-in-Residency is currently in progress at Valley High School.
