


Jump Into June with the SCOESC Curriculum Department!

Summer Learning Academy Update

South Central Ohio ESC offered a two-day Summer Learning Academy on June 4-5, 2025, that was free for all SCOESC educators.

Comprehensive School Threat Assessment Guidelines Training

All Ohio districts and schools can participate in training in the nationally recognized Comprehensive School Threat Assessment Guidelines (CSTAG). CSTAG allows school-based teams to follow a decision-tree process to resolve less serious, transient threats. Ohio's educational service centers (ESCs) will offer training in the CSTAG model to school and districts statewide.

Gifted Services Update



The 2025 Visually Literate High School Art Exhibition Reception was held at SSU on May 13th with nearly 200 people in attendance. The Portsmouth High School Jazz Band opened the evening, followed by an Awards Ceremony. Linden Crabtree

(Northwest High School)

took home \$300 for Best of Show and \$100 for the Art Teachers' Choice Award; she was also awarded a \$1,000 scholarship to study art at Shawnee State University next fall. Seven additional students from various districts won \$100 First Place Awards.

On May 8th, the 2025 Summer Enrichment Scholarship Reception at SSU recognized 17 students from six districts who received \$13,195 in scholarships to attend summer programs. With well over 100 people in attendance. SSU President, Dr. Eric Braun, welcomed attendees and talked about the importance of education. Macyn Johnson, senior at Clay High School and former summer scholarship recipient, spoke about her experiences with the SCOESC Gifted Programs and shared her musical talents with the audience. Additionally, nine students from five of our member districts were awarded full scholarships (\$9,720 total) to attend Miami University's Summer Scholars Program, made possible through the Scioto Foundation.

Lastly, the Books Build Bridges Literacy Committee is preparing for next year's countywide reading

initiative. Acclaimed author Jasmine Warga will visit Portsmouth on Thursday, March 12, 2026 meeting with sixth grade ELA students in the morning, SSU middle education majors in the afternoon, and hosting a public event at the Scioto County Public Library in Portsmouth that evening. The Books Build Bridges Committee is close to reaching its \$21,875 fundraising goal which will pay for Warga's visit, provide copies of A Rover's Story to every Scioto County 6th grader, and STEM related books for classrooms and school libraries.
